

# ORDINANCE 100

## CONSTRUCTION OF TOWN RECREATION HALL

EXTRACTS FROM THE MINUTES OF A REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE TOWN OF ELSINORE, HELD ON THE 8<sup>TH</sup> DAY OF JANUARY, 1938.

THE BOARD OF TRUSTEES OF THE TOWN OF ELSINORE CONVENED IN REGULAR SESSION AT THE TOWN HALL ON THE 8<sup>TH</sup> DAY OF JANUARY, 1938 AT 8 O'CLOCK P.M. THE MEETING WAS CALLED TO ORDER BY V.F. BRADLEY, TOWN PRESIDENT. THE CLERK OF THE BOARD OF TRUSTEES CALLED THE ROLL. ALL MEMBERS OF THE BOARD WERE PRESENT AS FOLLOWS: RULON NEWELL, LEGRAND JOHNSON, LORIN SYLVESTER, AND WALTER SMITH. AN ORDINANCE NUMBERED 100 AND ENTITLED "AN ORDINANCE PROVIDING FOR THE CONSTRUCTION OF A TOWN RECREATION HALL, PROVIDING FOR THE ISSUANCE AND SALE OF GENERAL OBLIGATION BONDS TO DEFRAY PART OF THE COSTS THEREOF" WAS INTRODUCED BY RULON NEWELL AND READ IN FULL AND CONSIDERED BY THE BOARD. IT WAS MOVED BY LORIN SYLVESTER AND SECONDED BY LEGRAND JOHNSON THAT ALL RULES OF THE BOARD OF TRUSTEES WHICH MIGHT PREVENT, UNLESS SUSPENDED, THE FINAL PASSAGE AND ADOPTION OF SAID ORDINANCE AT THIS MEETING, BE AND THE SAME ARE HEREBY SUSPENDED FOR THE PURPOSE OF PERMITTING AND FINAL PASSAGE AND ADOPTION OF SAID ORDINANCE AT THIS MEETING.

THE QUESTION BEING UPON THE ADOPTION OF SAID MOTION AND THE SUSPENSION OF SUCH RULES, THE ROLL WAS CALLED WITH FOLLOWING RESULTS:

AYES: WALTER SMITH, RULON NEWELL, LORIN SYLVESTER, LEGRAND JOHNSON. TOTAL 4.

NAYS: NONE

THE TOWN PRESIDENT DECLARED SAID MOTION CARRIED AND SUCH RULES SUSPENDED.

WALTER SMITH THEN MOVED THAT SAID ORDINANCE BE NOW PLACED UPON ITS FINAL PASSAGE. RULON NEWELL SECONDED THE MOTION.

THE QUESTION BEING PUT UPON THE PLACING OF SAID ORDINANCE UPON ITS FINAL PASSAGE, THE ROLL WAS CALLED WITH THE FOLLOWING RESULTS:

AYES: LEGRAND JOHNSON, RULAON NEWELL, WALTER SMITH, LORIN SYLVESTER. TOTAL 4.

NAYS: NONE

THE TOWN PRESIDENT DECLARED THE MOTION CARRIED.

LEGRAND JOHNSON THEREUPON MOVED THAT THE SAID ORDINANCE BE FINALLY PASSED AND ADOPTED AS INTRODUCED AND READ. LORIN SYLVESTER SECONDED THE MOTION.

THE QUESTION BEING PUT UPON THE FINAL PASSAGE AND ADOPTED OF SAID ORDINANCE. THE ROLL WAS CALLED WITH THE FOLLOWING RESULTS:

AYES: LEGRAND JOHNSON, RULON NEWELL, WALTER SMITH, LORIN SYLVESTER. TOTAL 4.

NAYES: NONE

THE TOWN PRESIDENT THEREUPON DECLARED SAID MOTION CARRIED AND THE ORDINANCE FINALLY PASSED AND ADOPTED.

THE TOWN PRESIDENT THERE UPON SIGNED SAID ORDINANCE IN APPROVAL THEREOF.
