ORDINANCE 1961-4

AN ORDINANCE ADOPTING THE UNIFORM TRAFFIC CODE FOR UTAH CITIES AND TOWNS PREPARED AND PUBLISHED BY THE UTAH MUNICIPAL LEAGUE, 1961, AS THE TRAFFIC CODE FOR THE TOWN OF ELSINORE

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF ELSINORE, UTAH:

SECTION 1. ADOPTION OF UNIFORM CODE. THE TRAFFIC CODE ADOPTED BY THE UTAH MUNICIPAL LEAGUE AS A CODE IN BOOK FORM ENTITLED "UNIFORM TRAFFIC CODE FOR UTAH CITIES AND TOWNS" PREPARED AND PUBLISHED BY THE UTAH MUNICIPAL LEAGUE IN 1961, IS HEREBY APPROVED AND ADOPTED AS THE TRAFFIC CODE OF THE TOWN OF ELSINORE, EXCEPT AS HEREINAFTER SPECIFIED AND BY THIS REFERENCE, PURSUANT TO THE PROVISIONS OF SECTION 10-6-12, UTAH CODE ANNOTATED, 1953, AS AMENDED, IS MADE A PART OF THIS ORDINANCE TO THE SAME EXTENT AND EFFECT AS THOUGH SAID CODE WERE COPIED IN FULL:

- A. ALL REFERENCES IS SAID CODE TO "CITY" AND TO ANY DEPARTMENT, AGENCY OR AGENT THEREOF, SHALL BE DEEMED TO MEAN THE TOWN OF "ELSINORE" AND ITS DEPARTMENTS, AGENCIES OR AGENTS.
- B. ALL REFERENCES IN SAID CODE TO THE "CHIEF OF POLICE" SHALL BE DEEMED TO MEAN MARSHAL AND REFERENCE TO THE "POLICE DEPARTMENT" SHALL BE DEEMED TO REFER TO THE TOWN'S LAW ENFORCEMENT DEPARTMENT.
- C. WHENEVER REPORTS ARE REQUIRED TO BE MADE TO THE "POLICE DEPARTMENT" SAID REQUIREMENTS, IN THE ABSENCE OF A SPECIAL POLICE DEPARTMENT CLERK, MAY BE DEEMED TO BE SATISFIED BY A REPORT FILED WITH THE OFFICE OF THE TOWN CLERK.

SECTION 2: PENALTIES. SECTIONS 15-5 AND 16-1 OF THE SAID UNIFORM TRAFFIC CODE ARE NOT HEREBY ADOPTED, AND IN LIEU THEREOF, THE FOLLOWING SECTIONS 15-5 AND 16-1 ARE ENACTED TO READ RESPECTIVELY AS FOLLOWS:

SECTION 15-5 – <u>PUNISHMENT</u>. EVERY PERSON CONVICTED OF VIOLATION OF SECTIONS 15-1 OR 15-2 SHALL BE PUNISHED BY IMPRISONMENT FOR NOT LESS THAN 30 DAYS NOR MORE THAN 3 MONTHS, OR BY A FINE IN AN AMOUNT LESS THAN \$100.00, OR BY BOTH SUCH FINE AND IMPRISONMENT.

SECTION 16-1 – <u>PENALTIES</u>. UNLESS ANOTHER PENALTY IS EXPRESSLY PROVIDED BY LAW, EVERY PERSON CONVICTED OF A VIOLATION OF ANY PROVISION OF THIS ORDINANCE SHALL BE PUNISHED BY A FINE IN AN AMOUNT LESS THAN \$100.00, OR IMPRISONMENT OF 3 MONTHS IN JAIL, OR BY BOTH SUCH FINE AND IMPRISONMENT.

<u>SECTION 3. EMERGENCY.</u> IN THE OPINION OF THE TOWN BOARD OF TRUSTEES, IT IS NECESSARY FOR THE PRESERVATION OF THE PEACE, HEALTH AND SAFETY OF THIS TOWN THAT THIS ORDINANCE SHALL BE EFFECTIVE IMMEDIATELY.

<u>SECTION 4. EFFECTIVE DATE</u>. THIS ORDINANCE SHALL TAKE EFFECT UPON THE DATE OF ITS FIRST POSTING, NOVEMBER 3, 1961.
